Street parking or driveway access likely available. Best attempt: evening weekdays or weekend mornings when the subject is not commuting to St Paul. The previous plate WR7B22 was carried over from the prior 2023 Honda Pilot, indicating continuous use of this plate by the household.

5. Final Thoughts

⚠️ The target vehicle — 2025 White Honda Pilot Touring (VIN: 8FNY9852F234RT2589, 896DS2) — is currently registered to the subject and spouse at 9876 Hudson St NE, Minneapolis, MN 55418, an owner-occupied single-family home on a large lot with driveway access. Recovery confidence at this address is high. The primary complication is the subject's active CTO role in St Paul (~30 miles away), meaning the vehicle may be at 9876 Washington Blvd, St Paul, MN during weekday business hours. Evening or weekend attempts at the Minneapolis residence are the recommended primary window. If not located there, a drive-by of the St Paul office is the logical secondary. The 6688 Loon Call Dr, Minneapolis, MN address appearing in two corporate filings is a low-probability tertiary check. No concealment indicators, no hostility flags, and a verified high-confidence phone number (222) 888-1234 are all favorable for a straightforward recovery.
